FOR THE ACQUISITION OF TRACTORS FOR THE BENEFIT OF THE DIRECTORATE OF AGRICULTURAL DEVELOPMENT, EQUIPMENT, AND MECHANIZATION (DAEMA)

- 1. The Government of the Togolese Republic has received funds from the Government of Japan to finance the Support Project for Agricultural Mechanization in Togo and intends to use a portion of this financing to make payments under the Contract for the acquisition of tractors for the benefit of the Directorate of Agricultural Development, Equipment, and Mechanization (DAEMA).
- 2. The Ministry of Agriculture, Livestock, and Rural Development (MAEDR), acting on behalf of said project, solicits sealed bids from eligible bidders meeting the required qualifications to provide the tractors (single lot).

The delivery period is 4 months from the date of notification of the approved contract. Variants are not allowed.

- 3. The procurement of the Contract will be conducted through an Open Tender as defined by the current Public Procurement Code and its implementing texts, and open to all candidates.
- 4. Eligible and interested bidders may obtain information from the project coordination for the support of agricultural mechanization in Togo, located at Avenue de la Nouvelle Présidence, Ministry of Agriculture, Livestock, and Rural Development, GTA behind the TOGOCOM company, last building before the new Presidency of the Togolese Republic,

- 6. Interested and eligible Bidders may obtain a complete bidding document in French at the address below and against a non-refundable payment of 100,000 CFA Francs (Approx. 153 Euro). The payment method will be hand to hand against a receipt.
- 7. Bids must be submitted to the address mentioned in point 9 no later than June 13, 2024 at 09:30 UTC. Submission of bids electronically will not be allowed. Late bids will not be accepted.
