#### **Project Title:**

#### **Localized Repairs to Depot Perimeter Walls, Pipeline Gratings, Supporting Structures, Rehabilitation of Internal Roads, and Parking Lot**

The Complexe Pétrolier de Lomé (COMPEL) is inviting bids for the following works under its 2024 budget:

1. Localized repairs of the depot perimeter walls, pipeline gratings, and supporting structures at drainage channels.
2. Rehabilitation of internal roads and parking facilities within the depot.
3. Reshaping of the exit road leading from the depot to the northern perimeter fence.

This call for tender is divided into three lots:

- **Lot 1:** Localized repairs to depot perimeter walls, pipeline gratings, and supporting structures.
- **Lot 2:** Rehabilitation of internal depot roads and parking facilities.
- **Lot 3:** Reshaping of the exit road up to the northern perimeter.

The execution period for each lot is four (4) months, and variations are not permitted.
